- ☐ **SPECIAL LIMITED TIME OFFER FOR SPRING/SUMMER NEWTIQUE SHOW - BOOK NOW AND SAVE \$15!:** Pay discounted fee of \$25 for each space. Vendor must bring their own tables/chairs/setups and must fit within the approximate 8' x 6' space. Add \$20 for 2nd setup, if desired. SETUP MAY NOT BE SHARED WITH OTHERS!

2023 vendors have first right of refusal until October 30th. At that time, un-reserved space will be opened to other vendors

- Vendors provide their own table/table coverings/setups and displays. Fee is for space and 2 chairs only.
- Vendors will be located on both sides of the building
- Signage will direct traffic to both sides of the building

Must Reserve Prior to Nov. 1, 2025: \$5 additional for ONE electrical outlet (limited availability, must provide own extension cord). First reserved – first served. PLEASE DO NOT REQUEST ELECTRICITY THE DAY OF SETUP!

FACILITY: While backdrops or displays are welcome, **nothing may be affixed to the walls or floors at the facility.**

2025 Holiday Bazaar - Vendor Terms & Release Form

**This application form is a contract and legally binding;
please read carefully before signing.**

In consideration of the 2025 Holiday Bazaar Vendor Application, I, the undersigned, ("Vendor") am authorized to sign for Vendor and assume full and complete responsibility for any injury or accident which may occur during my participation in the 2025 CCCC Club Auxiliary Holiday Bazaar, including but not limited to the time that I or any individuals or parties acting on my behalf are on the premises of the event. I hereby release and hold harmless the sponsors, promoters and all other persons and entities associated with this event (collectively known as "CCCCClub"). I additionally assume full liability and responsibility for any property damages caused by in part or in entirety by my sole participation, or by the participation of any employees or individuals acting on my behalf at, or in conjunction with this event. I understand my participation implies my acceptance of these terms.

I further agree and understand that I, as a Vendor and participant, release CCCCClub Holiday Bazaar from any and all responsibility of liability of any kind for any loss, injury or damage of any kind to the Vendor or Vendor's property or merchandise. All expenses of transporting, packing, unpacking and insuring Vendor's property or merchandise shall be the sole responsibility of the Vendor. CCCCClub Holiday Bazaar may cancel the Bazaar and/or Vendor's area at any time at its sole option. The only liability which CCCCClub Holiday Bazaar has to the Vendor in the event of CCCC Club cancellation of event, shall be the refund of all fees paid by the Vendor, which were received by CCCCClub Holiday Bazaar prior to such cancellation.

While CCCCClub Holiday Bazaar does secure the facility when the bazaar is closed, the CCCC Club, nor organizers accept responsibility for the loss of goods, merchandise, displays, or other materials resulting from fire, flood, theft, vandalism, acts of nature or any other cause. Vendors are hereby advised that CCCCClub Holiday Bazaar will not carry insurance to cover damage/loss sustained by Vendors, personnel, and/or guests.

All fees are due at the time of submission of the Vendor Application. Vendor fees are non-refundable, if the vendor cancels. Vendors are responsible for providing their own displays or other items needed for the efficient operation of their booth. **Nothing may be affixed to the floor, walls, ceiling or any of the premises of the Holiday Bazaar location.**

All proceeds of a Vendor's sales shall be retained by the Vendor, and each Vendor is responsible for the collection and remittance of all taxes relating to its sales and for indemnification of and holding the CCCCClub Holiday Bazaar harmless from any failure by the Vendor to collect and remit such taxes in accordance with applicable law.
